MEDIA ADVISORY: COMED ANNOUNCES \$70 MILLION IN EV REBATES AVAILABLE TO CUSTOMERS IN 2026

ComEd to detail how customers can apply for EV rebates aimed at reducing up front barriers and boosting EV adoption in northern Illinois

What: ComEd will announce 2026 funding for electric vehicle (EV) rebate programs offered in 2026 to help residential, business and public sector customers planning to transition to EVs.

The 2026 ComEd rebate programs will offer customers access to approximately \$70 million in funding opportunities designed to remove barriers and promote widespread adoption of EVs and expansion of charging infrastructure in northern Illinois. The funding covers three rebate offerings: The Residential EV Charger and Installation Program, the Business and Public Sector EV Purchase Program and the Business and Public Sector Make-Ready Program.

First launched in 2023, ComEd EV programs aim to reduce upfront cost barriers to EV projects in northern Illinois and place an emphasis on equity. More than half of all EV funds will be reserved for applicants from or serving low-income and equity communities, with customers meeting these criteria also eligible for funding in higher amounts.

ComEd will join its EV partners from across the region in making this announcement, which comes as Illinois continues to see significant growth in EV adoption, a target highlighted in the 2021 Climate and Equitable Jobs Act (CEJA) passed by the state of Illinois. There are currently more than 160,000 EVs registered in Illinois today, 90 percent of which are in ComEd's service territory.
